ADOPTION OF THE STATE OF CALIFORNIA CODES – an Ordinance of the City Council of the City of Huntington Beach Amending the Huntington Beach Municipal Code by amending Chapters 17.04, 17.07, 17.40, 17.44, 17.48 to adopt by reference the 2016 California: Building, Residential, Mechanical, Plumbing, and Electrical Codes and the whole thereof; Repeal 17.06 of the Huntington Beach Municipal Code relating to the 2016 California Green Building Standards Code, save and except such portions that hereafter are modified, amended or deleted by the proposed ordinances; and amending Chapters 17.46 and 17.60 to adopt by reference the 2015 editions of the Uniform Swimming Pool, Spa and Hot Tub Code, and the Solar Energy and Hydroponics Code as compiled by the International Association of Plumbing and Mechanical Officials and the whole thereof, save and except such portions that hereafter are modified, amended or deleted by the proposed ordinances, and amending Chapters 17.08 Housing Code.
