CATEGORIES AND GUIDELINES:

NOMINATIONS:

- Must emphasize outstanding work completed within the last two calendar years (2012-2013).
- Nominees must live, work or present in the City of Huntington Beach.
- Individuals, businesses, corporations, nonprofit arts organizations, government agencies and educational institutions are all invited to submit their candidates. Self-nominations are also accepted.
- Nominations in several categories are encouraged.
- If no nomination is received for a specific category, no award will be given.

CATEGORIES:

Each candidate will be considered *only* in the category for which they are nominated.

Distinguished Arts Administrator

Recognizes individuals that direct or manage arts organizations or programs in a paid leadership position.

Distinguished Arts Educator

Recognizes individual arts educators in K-12 schools, school districts, colleges or universities who demonstrate unique community partnerships, exemplary curriculum, and the philosophy that the arts are integral to a balanced education.

Distinguished Arts Organization

Recognizes a professional organization whose activities include the creation, production, and/or presentation of dance, theatre, music, exhibitions, multidisciplinary programming or community outreach efforts.

Distinguished Business Support

Recognizes individuals, businesses or government agencies that demonstrate outstanding philanthropic commitments to the arts including financial support, involvement and/or leadership.

Distinguished Performing Artist

Recognizes a professional who has demonstrated outstanding artistic accomplishments, training or inspiring others in the art form, or a collaboration that has made a contribution in music, dance or theatre.

Distinguished Visual Artist

Recognizes a professional artist who has demonstrated outstanding artistic accomplishments, training or inspiring others in the art form, or a collaboration that has made a contribution in the visual arts.

Distinguished Volunteer

Recognizes individuals or support groups serving the arts whose personal efforts have helped to forward programs and activities.

Exceptional Youth in the Arts

Recognizes children 18 years and younger who have excelled in the visual or performing arts through their discipline, or who has trained or inspired others in the art form.

Public Art Project of the Year

Recognizes permanent or temporary art, or site-specific or performance art.
