DETAILS: ———On 02/02/2007 at 0307 hours, a lone male suspect entered the Hotel Huntington Beach and robbed the front desk clerk armed with a metal baton. The suspect fled the location with an undetermined amount of U.S. currency.

A few minutes later, Officers saw Rodney Sims at the Mobile gas station at Beach and Edinger. He matched the description of the robbery suspect and drove away in the listed vehicle. Officers attempted a car stop on Sims and he fled. Officers pursued Sims northbound on the 405 freeway. Sims exited the freeway at Manchester in the city of Inglewood. Officers did a P.I.T. maneuver which stopped the suspect vehicle.

Sims refused to exit the vehicle. An officer shot out the passenger window with a “Bean Bag” round. Sims then complied with the officers orders and surrendered without further incident.

Sims was on parole for robbery at the time of his arrest. A metal baton and U.S. Currency was found in the suspect vehicle.
