



# SB 205 Stormwater Discharge Compliance Form

Certain businesses in the State are required under the National Pollutant Discharge Elimination System ("NPDES") permit program and related California law to obtain permits to discharge waste into storm waters. Governor Newsom signed SB 205 into law where beginning January 1, 2020, the State requires that businesses that are regulated NPDES industries applying to a city for an initial business license or business license renewal demonstrate enrollment in the NPDES permit program, including the Standard Industrial Classification Code ("SIC") for the business. SIC is a system for classifying industries by a four-digit code. By providing a SIC code on a City business license application, the City can verify required NPDES enrollment.

SB 205 **DOES NOT** affect all commercial based businesses, any home based businesses, or any business that does not operate from a brick and mortar location in Huntington Beach. Only businesses with primary SIC codes that are identified by the State Water Board as requiring NPDES enrollment are affected.
