Incredibly, the same politicians who believe they should dictate how Californians work, have released thousands of felons onto the streets during the lockdown, while criminalizing millions of people who are attempting to keep a roof over their families' heads and educate their children. The irony is apparently completely lost on the political class.

The condition of California's economy, forests, electric grid, crime rates and oppressive tax system make it safe to suggest that the politicians ruining our state are not the best determiners of anything with respect to individuals and their choices when it comes to providing for their families.

Elections matter. Exercise your right to vote in 2020.


