### Fitness Center Policies & Procedures

#### Membership

- A \$6 processing fee and proration fees will be charged if a refund is requested within one month of sign-up. **After one month no refunds will be granted.**
- **All members must be able to get on and off equipment by themselves. Caregivers, outside trainers, and family members may not accompany members or use the facility.**
- Membership holds and/or extensions will not be granted regardless of injury, number of uses, etc.
- Fitness Center use is for members only; there is a no guest policy.
- All those entering the fitness center must have a membership, unless coming for class or a screening.
- All members must complete the registration paperwork annually.
- Members participate at their own risk; Huntington Beach is not responsible for any injury that may occur while using the equipment. Participation in the exercise activity is on a voluntary basis.
- A current Fitness Center membership card must be presented at each visit. There will be a \$5 replacement fee for lost or stolen cards.

#### Fitness Center Use

- Appropriate clothing and athletic shoes must be worn at all times. **No flip flops or open-toed shoes.**
- **Smoking, pets, gum, food, drinks other than water, or outside equipment are not permitted in Fitness Center.** A secure closure is required on all water bottles.
- **Use of cardiovascular equipment is limited to 30 minutes while others are waiting to use the equipment or during peak hours.**
- **Use of strength or stretching equipment is limited to 5 to 6 minutes while others are waiting or during peak hours.**
- The use of cell phones to play music or video while inside the Fitness Center is prohibited.
- The Personal Training Studio and its accessories are only available for use when classes are NOT taking place.
- Equipment must be wiped down after each use.
- Use of the exercise equipment may be restricted to anyone whose health or actions may be unsafe to themselves or others based on the discretion of Wellness Pavilion staff.
- The use of heavily scented perfumes and colognes is prohibited.
- Personal items must be stored in the cubby holes. No items may be left on the floor.
- Music, TVs, and room temperature will not be adjusted.
- The City of Huntington Beach is not responsible for lost, stolen, or damaged property left in the Health & Wellness Pavilion.
