Clothes Dryer Safety

Doing laundry is part of every family's routine. Taking care of your clothes dryer is important to the safety of your home. With a few simple safety tips, you can help prevent a clothes dryer fire.

- Have your dryer installed and serviced by a professional.
- Do not use the dryer without a lint filter.
- Make sure you clean the lint filter before or after each load of laundry. Remove lint that has collected around the drum.
- Rigid or flexible metal venting material should be used to sustain proper air flow and drying time.
- Make sure the air exhaust vent pipe is not restricted and the outdoor vent flap will
 open when the dryer is operating. Once a year, or more often if you notice that it is
 taking longer than normal for your clothes to dry, clean lint out of the vent pipe or have
 a dryer lint removal service do it for you.
- Keep dryers in good working order. Gas dryers should be inspected by a professional to make sure that the gas line and connection are intact and free of leaks.
- Make sure the right plug and outlet are used and that the machine is connected properly.
- Follow the manufacturer's operating instructions and don't overload your dryer.
- Turn the dryer off if you leave home or when you go to bed.

FACT

The leading cause of home clothes dryer fires is failure to clean them.

And Don't Forget...

- Dryers should be properly grounded.
- Keep the area around the dryer clear of things that can burn (boxes, cleaning supplies, clothing, etc.)
- Clothes that have come in contact with flammable substances like gasoline, paint thinner, or similar solvents should be laid outside to dry, then can be washed and dried as usual.

Zoning Administrator

On Wednesday, June 19, 2013, at 1:30 p.m. in Room B-8, the Zoning Administrator will review the following items:

- 1. <u>Mitigated Negative Declaration No. 11-012</u> (Beach Boulevard and Warner Avenue Intersection Improvements): To analyze the potential environmental impacts associated with the construction of a westbound right turn lane on Warner Avenue at the intersection of Beach Boulevard and associated improvements including a new five-foot wide sidewalk along the west side of A Lane for a length of approximately 150 feet. The property is located at Intersection of Beach Boulevard and Warner Avenue (north side of Warner Avenue from Beach Boulevard to 65 feet east of A Lane). - 2. Conditional Use Permit No. 13-015 (Ramirez Block Wall): To permit the construction of a 6 ft. 11 in. high front yard wall in lieu of the maximum height of 42 in. and a 1 ft. 6 in. setback in lieu of 12 ft. within the front yard setback area. The property is located at 214 Venice Avenue, 92648 (north side of Venice Avenue, between Alabama Street and Huntington Street). Please contact Kristi Rojas for more information.
- 3. Coastal Development Permit No. 13-005 (San Clemente Single Family Residence): To permit the demolition of an existing single-family residence and construct a new approximately 5,197 sq. ft. 2-story, single-family residence within the appealable area of the Coastal Zone. The property is located at 16262 San Clemente Circle, 92649 (southeast side of San Clemente Circle, Huntington Harbour). Please contact Ethan Edwards for more information.
- 4. Conditional Use Permit No. 12-091/Coastal Development Permit No. 13-007 (Bark City Dog Daycare Facility): To permit the establishment of a dog daycare facility, including the placement and operation of two one-story modular structures totaling approximately 2,160 sq. ft. within the appealable area of the Coastal Zone. The property is located at 8451 Edison, 92646 (north side of Edison Drive, between Newland Street and Beach Maintenance Yard). Please contact Ethan Edwards for more information.

POLICE DEPARTMENT

Storage Burglary Investigation 13-007388

During the later part of May, the Huntington Beach Police Department began receiving reports from citizens informing us of burglaries involving their storage units located at Extra Space Storage, 7531 McFadden Ave in the City of Huntington Beach. The combined value of the property loss was estimated at over \$200,000.

The initial investigation led to a surveillance of the storage facility, which ultimately resulted in the arrest of three suspects. The suspects were identified as Lisa Sanford, 42, of Huntington Beach; James Hayes, 47, of Westminster, and John McGowen, 45, of Seal Beach. Subsequent investigation resulted in the service of a search warrant in Westminster, where numerous items of stolen property were recovered including a 25' cargo box truck full of property. Through continued investigation, we were able to identify stolen items from other unsolved theft cases.

Keep Your Valuables Secure or Keep an Eye on Them While Enjoying the Beach

On May 27, 2013, a motorcycle officer was flagged down near the beach regarding the theft of a backpack that had just occurred. Beach Patrol officers were provided a description of the suspect who was located a short time later still in possession of the backpack and its contents. The suspect was arrested. The backpack was returned to the owner, and after the officers' investigation, the 19 year-old suspect from Anaheim was released from custody with a scheduled court date.

Saturday afternoon, Beach Patrol recognized the same subject on the beach. He was walking along the sand and occasionally sitting next to towels with unattended backpacks and other property, trying to blend into the crowds. The officers contacted him and determined he was in possession of a stolen mobile phone. The officers called the owner of the mobile phone who said it had been stolen from the beach earlier in the morning near Tower 1. Our officers arrested Ryan Michael Moretto again, and booked him in the Huntington Beach city jail for possession of stolen property. The stolen mobile phone was returned to the owner.

Traffic Enforcement Stop Leads to Arrests

Friday night at about 10:25 p.m., a police officer stopped a new vehicle with no license plates for a traffic violation on Adams Avenue east of Beach Boulevard. While talking with the driver, the officer discovered the driver was currently on parole and not in compliance with his parole terms. Further investigation revealed the vehicle, a 2013 Infinity G37, was a stolen vehicle.

PUBLIC WORKS

Central Park Parking Lot Improvements

On June 17, 2013, the City Council awarded a construction contract to GMC Engineering to rehabilitate the Slater Avenue parking lot in Central Park. The parking lot was subject to closure during rain events due to its deteriorated state. The project will include re-grading to alleviate flooding, with runoff being directed to a new vegetated bioswale, which will provide treatment of the runoff prior to entering the storm drain. It is anticipated that the total cost, including design and construction, will be approximately \$350,000.
